## GOVERNMENT PRESS STATEMENT

The Minister has declared TIME magazine as a gazetted publication within the meaning of Section 18A(1) of the Newspaper and Printing Presses Act. The Order, issued in the Gazette today will take effect on 19 Oct 86.

In the issue dated 8 September\*, 1986, TIME magazine published an article on Singapore which contained several important errors of fact. It was written by a correspondent who had specially flown in from Bangkok for a short visit to write it up.

On 3 September, James Fu, Press Secretary to the Prime Minister, wrote to TIME magazine requesting that they publish his correction of these errors.

On 24 September, James Fu sent a further note reminding them of this letter. A telex was also sent to William Stewart, TIME's Bureau Chief in Hongkong on 25 September, requesting him to publish the letter after he called James Fu.

On 30 Sep, James Fu received a letter dated 23 Sep from Joan Walsh of TIME magazine, New York, explaining why despite the errors, TIME magazine will not publish the letter. She also wrongly claimed that a government official had confirmed the accuracy of one of the errors pointed out.

On 2 October, James Fu wrote again to TIME.

On 3 October, Leah Gordon of TIME called the Singapore's Permanent Representative at the United Nations to negotiate the printing of James Fu's letter. She wanted to edit the letter before publication. She was asked to publish the letter unaltered. On 10 Oct, Leah Gordon submitted another edited letter. She was again requested to publish James Fu's letter unaltered.

Despite repeated requests, TIME have refused to publish James Fu's letter of correction in full and unaltered. In view of this, the Government is restricting TIME's circulation to 9,000 copies as from 19 October and to 2,000 copies as from 1 January 1987.

It is the practice of the foreign correspondents to give each other cover and support. Some of them believe that the regional journals which depend on Singapore for a high percentage of their circulation need help in putting the Singapore Government in its place. The amendment to the Newspaper and Printing Presses Act is to discourage foreign publications from biased reporting on Singapore. Persistent refusal to publish corrections is an example of bias. Since TIME sell only 18,000 copies in Singapore each week, i.e. 0.3 per cent of their total worldwide circulation, they believe they can afford to ignore a letter from Singapore to correct misreporting.

The publisher has been notified and advised to nominate a distributor of authorisation in accordance with Section 18 (A)(2) of the Newspaper and Printing Presses Act. The restricted copies will be marked. The marked copies will be made available in public and other libraries listed in the "Directory of Libraries in Singapore".

Attached are copies of letters by James Fu to TIME and TIME's replies.

Your article on Singapore of September 8 contains errors of fact.

Judge Michael Khoo did not "dismiss all the charges except for a minor technicality". He convicted Mr Jeyaretnam on one charge of disposing of assets to defraud creditors, an offence under Section 421 of the Penal Code which carries a maximum sentence of two years jail. He was fined \$1,000.

Next, the Chief Justice did not "overturn Judge Khoo's ruling and sentenced Mr Jeyaretnam to three months in jail". He reversed Judge Khoo's acquittals on two charges of defrauding creditors, and fined Mr Jeyaretnam \$1,000 on each charge. In the same judgment, Chief Justice ordered a retrial by a different Judge of the charge against Mr Jeyaretnam of giving false evidence in a statutory declaration, an offence under Sections 193 and 199 of the Penal Code punishable up to 7 years jail.

At the retrial, a different Judge found Mr Jeyaretnam guilty and sentenced him to three months.

Further, the Singapore Government did not introduce any Constitutional amendment which would deny counsel for an MP cited for contempt. There was no need to. British Parliamentary practice, which Singapore follows, does not allow counsel for MPs cited in Parliament for contempt of Parliament.

Dear Mr. Fu:

Thank you very much for your recent letter in response to our September 8 story, "Silencing the Dissenters." We appreciate being given the opportunity to discuss the points you raised.

It is our understanding that a bill was introduced in Parliament on August 25 that would deny the right to counsel for an MP cited for contempt. This information was confirmed before publication in TIME. The same facts were later reported in an article in the August 29, 1986 issue of The Straits Times which began: "Any person who is committed for contempt of Parliament will lose his right to be represented by a lawyer under changes to be made to the Constitution." TIME believes that articles in The Straits Times are normally reliable reflections of the government's views. An officer of the government press office confirmed the accuracy of TIME's report on this point.

Similarly, in the context of the complexities of this case, we felt it was not inaccurate to report the dismissal of all charges "except for a minor technicality" against J.B. Jeyaretnam. TIME chose this language in an attempt to place the conviction, which was part of a highly complicated legal proceeding, in context for TIME's readers. When Judge Khoo chose to convict Jeyaretnam of one of the charges, he fined him the equivalent of only 465.11 in U.S. dollars. We would suggest that if Judge Khoo had decided there had been a blatant violation of the statute, he would have chosen a more serious penalty. We have, however, noted your opposition to our usage.

On your final point, we accept your correction that we were in error when we directly linked Court Chief Justice Wee Chong Jin with Jeyaretnam's three month sentence. As you say, he ordered a retrial and a different judge imposed the sentence. We very much regret the error and have adjusted our story files.

We regret that we could not publish your letter, but we thank you again for taking the time to write. We value your interest in our reporting, and hope that we have addressed your criticism of our article. Should you wish to reply or raise any other points, please be assured that your letter will be given every consideration.

*Proposed Letter (edited by TIME)*

Your article on J.B. Jeyaretnam [Sept. 8], who is a member of the opposition in Singapore's parliament, contains a errors and misinterpretations. Jeyaretnam and others in his party were prosecuted for alleged improper use of party funds and making false declarations. But contrary to what you reported, Judge Michael Khoo did not dismiss "all the charges except for a minor technicality." He convicted Jeyaretnam on the charge of disposing of assets to defraud creditors and fined him \$1,000 Singapore dollars (\$465 U.S. dollars). I do not consider that a minor technicality.


Chief Justice Wee Chong Jin did not overturn Judge Khoo's ruling and sentence Jeyaretnam to three months in jail, as you say. Instead, the Chief Justice reversed Judge Khoo's acquittals on two charges of defrauding creditors and fined Jeyaretnam \$1,000 Singapore dollars on each charge. In the same judgment the Chief Justice ordered a retrial by a different judge. The charge against Jeyaretnam in this case was for giving false evidence in a statutory declaration. At the retrial, the new judge found Jeyaretnam guilty and sentenced him to three months in jail.

Further, the Singapore Government did not introduce any constitutional amendment which would deny counsel for an MP cited for contempt. There was no need to., British Parliamentary practice, which Singapore follows does not allow counsel for MPs cited in Parliament for contempt of Parliament.


